- ➤ **Port Drayage/Truck Transport** When ag exporters (and importers) compete on delivered price, every wasted dollar cuts into the margin. Inland and port drayage is a costly part of the export business, and every exporter has horror stories.
- ➤ Chassis In just 5 short years the chassis situation has gone from clarity (part of the basic ocean carrier service) to chaos where most, but not all, of the steamship lines have stopped providing chassis "for free", except when they still do provide the chassis. Each port and inland terminal has its own practice, and each steamship line has its own rules in each port.
